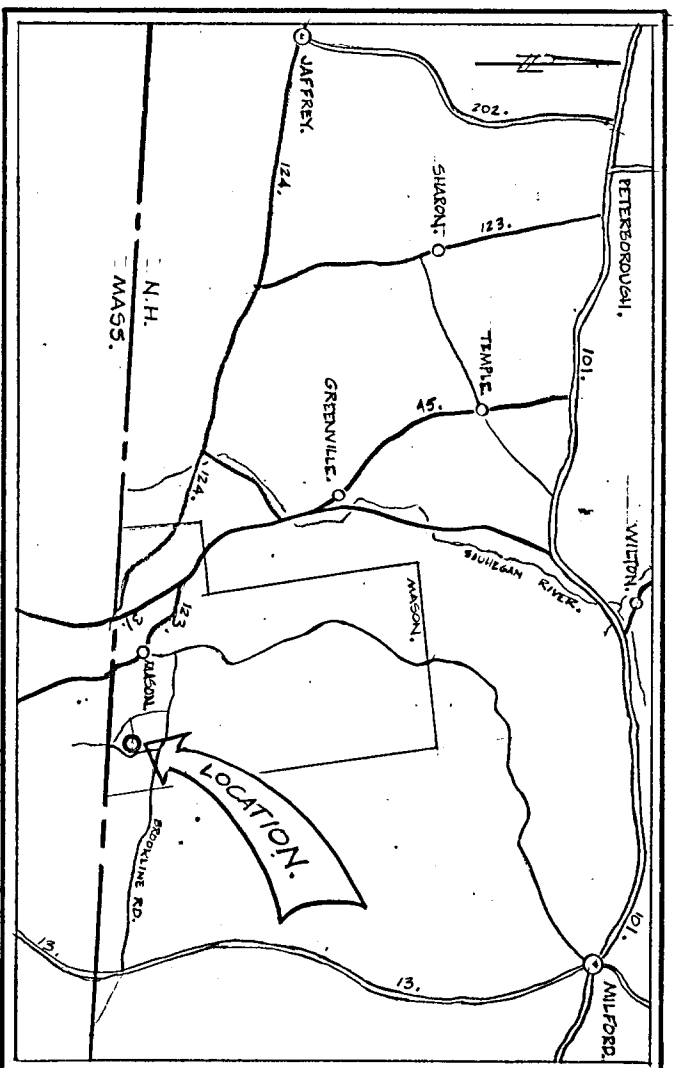

USGS QUAD. TOWNSEND, MASS.

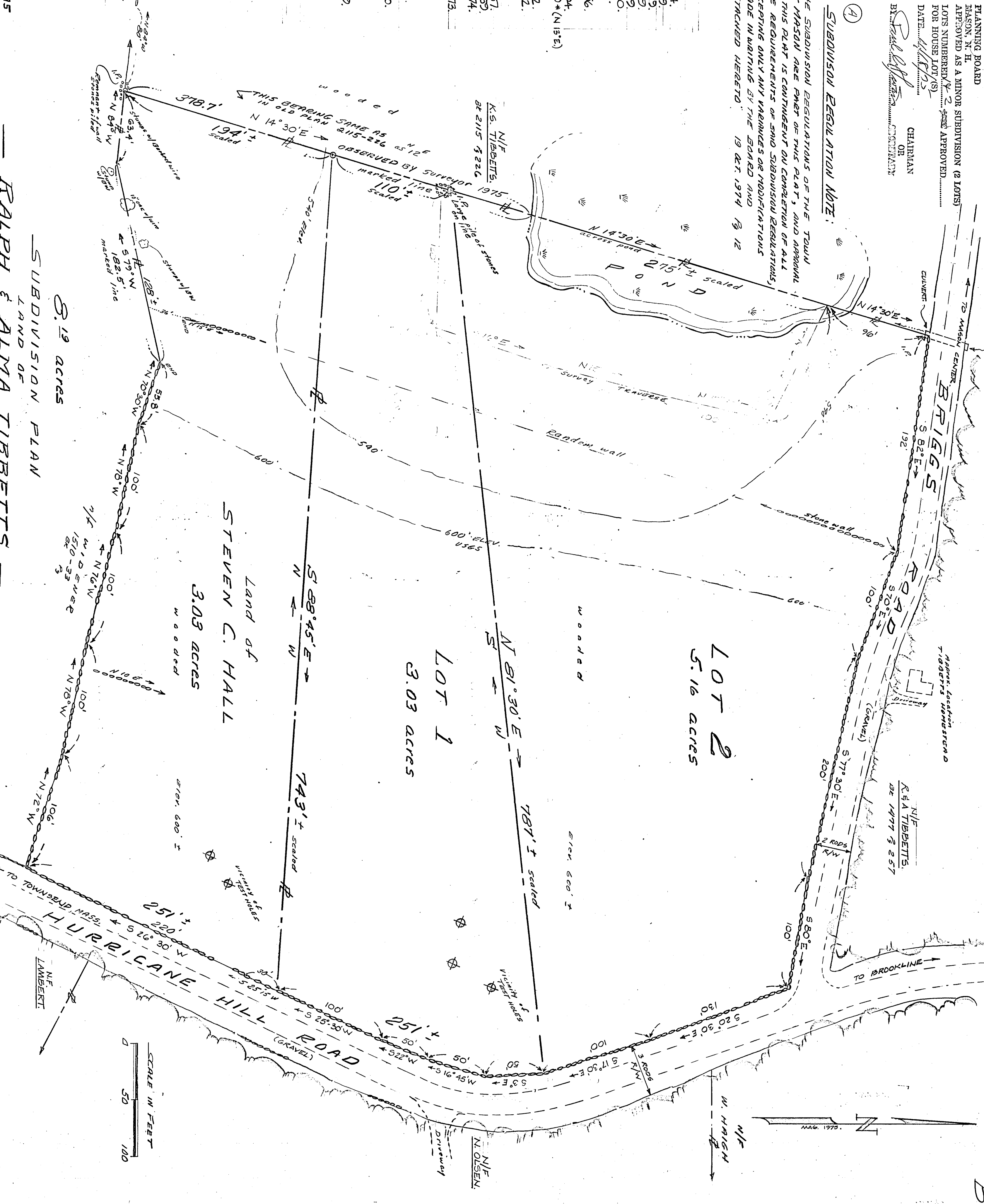

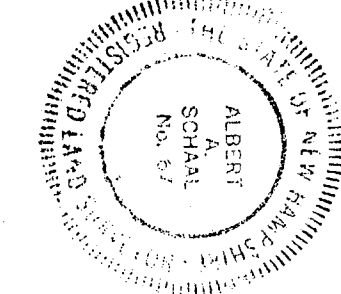
