SITE LOCATION MAP

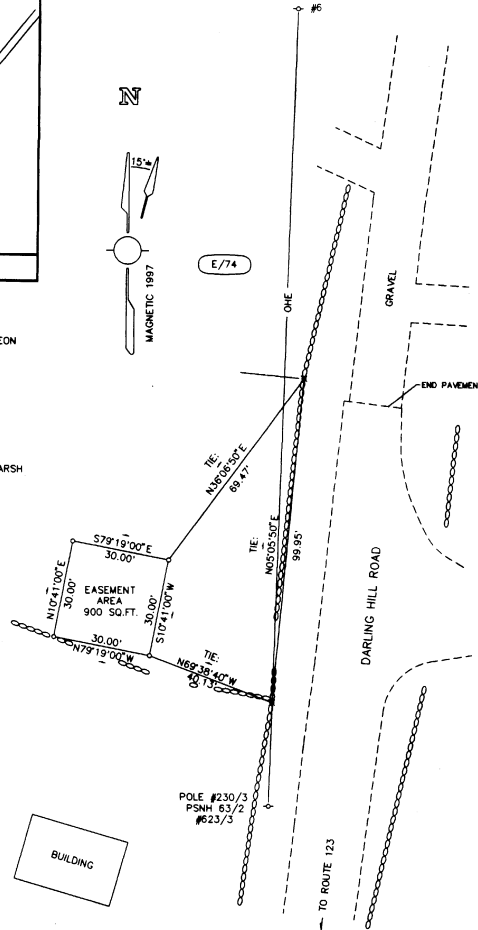

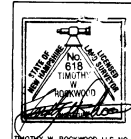
