# **Establish Funding**

NH Charitable Foundations may be a source of income. Town could create a donor fund in hopes that people might contribute or bequest money.

Bonding for Broadband Service Bill in Concord is in interim study committee; legislators are defining "adequate broadband"; towns are permitted by law to bond for broadband structure.

Steve Hoffman, Mason Broadband Committee discussed possibility of WiFi Coverage for underserved areas of Mason.

Brian T, CEO of WiValley Broadband Solutions, provided an overview of his company as a provider with hybrid solutions to cost effectively expand service areas. Also suggested the advantage of running fiber optic cable alongside the pipeline.
